### Dress Code 2021-2022 for K-12

- New Update– K-12 can wear athletic shoes (must cover entire foot) - with the exception of light up shoes, musical shoes, or shoes with wheels. We're no longer requiring all black shoes for 9-12.
- We will be following the school handbook policy for hair which includes **natural colored hair dyes and styles only.**
- No flip-flop, sandals, or open toed shoes are permitted.
- Horizon polo should be worn at all times- **blue or orange for grades K-8 and maroon or navy for grades 9-12.**
- Tan or navy blue pants-**NO BLACK.**
- Skirts/Shorts must be to the knee and must be tan or navy blue (grades K-5 only).
- Jackets/coats are not permitted during the school day.
- No boots (snow or fashion) are permitted during the school day.
- Students need to have a Horizon logo on their clothes (shirts, sweaters) at all times along with the appropriate pants.
- Horizon Hoodies can be worn **EVERYDAY** as opposed to Fridays only (hood part of the sweater should not cover their head throughout the day). If students are cold, they can also wear solid color long sleeve shirt or solid color sweater underneath their Horizon Polo.
- Headphones, cell phones, and smart watches are not permitted throughout the day and need to be in their locker. We encourage purchasing a lock for your locker to secure any electronics. HSA is not responsible for lost or stolen phones or electronic devices such as i-pods, music players and tablets.
- Horizon spirit wear can be worn on Fridays (club t-shirts, class trip t-shirts, sports attire with logo, Hype Squad attire, and science fair/robotics t-shirts).
- No novelty headbands (unicorn, cat, etc...).

**Failure to adhere to these guidelines will result in consequences for your student.**

- First violation is a written warning.
- Second violation is morning detention with parent phone call.
- Third violation is a half-day ISS and a parent meeting. (In School Suspension).
- Fourth violation is one day ISS.
- Fifth violation is OSS (Out of School Suspension).

Further violations may result in a behavior contract.

### **ELECTRONIC DEVICE/CELL PHONE POLICY**

**NO CELL PHONES SHOULD BE SEEN OR HEARD DURING SCHOOL HOURS.** If a parent would like their student to bring an electronic device/cell phone to school, the student will have to keep their electronic device/cell phone in their locker at all times while at school. At the end of the day the student will be able to go to their locker and get the electronic device/cell phone back. If students are caught with a electronic device/cell phone throughout the day the electronic device/cell phone will be taken and it will be returned upon written request from the parent. If an electronic device/cell phone is taken from a student on three separate occasions, that student will no longer be permitted to have an electronic device/cell phone on school grounds. If a student is found with an electronic device/cell phone on a fourth occasion, it will become an office referral with additional consequence. **HSA is not responsible for lost or stolen phones or electronic devices such as i-pods, music players and tablets.**
